

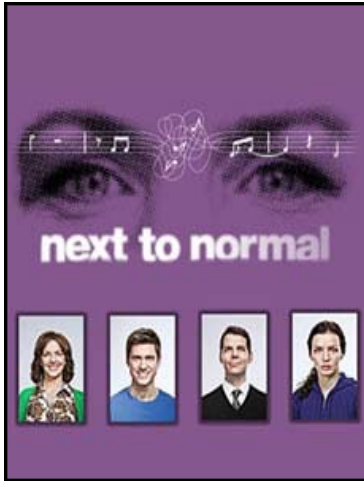

Magnolia Clubhouse is pleased to invite the community to see “**Next to Normal**”, an emotional powerhouse of a musical with a thrilling contemporary score about a woman grappling with bipolar disorder, and her family,

as they try to take care of themselves and each other.

Magnolia Clubhouse Executive Director, Lori D’Angelo saw the show in previews and has this to share: “ Ultimately, the show depicts hope and growth, the core components of the Clubhouse. ‘**Next to Normal**’ provides a vehicle to further the understanding of mental illness and the lives of people who live with it. In this show, as in the Clubhouse, you get to know the person first, not just the symptoms of an illness. Often mental illness is depicted as a very frightening and alien experience. Unfortunately this can lead people to fear those who experience mental illness, and can lead to shame for those who are dealing with it themselves. What we see in the Clubhouse model is that acceptance is achieved by coming to know our profound connections with each other. The more we can accept our own fears and experiences of aloneness and despair, the more we are able to deal with and overcome them. Working together with the shared purpose of the Clubhouse develops all of our abilities to accept, connect, heal and grow.” (See page 3 for more information)

**Welcome to our newest board members:**

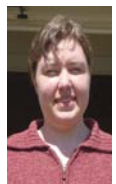


**Robert F. Spada** is the Vice Chair of the State Employment Relations Board. He was appointed for this position during his 10th year in the Ohio Senate representing the 24th Senate District from Cuyahoga County. He served two terms as Assistant Majority Floor Leader. His Committee assignments included Health; Finance; Ways & Means; Energy & Natural Resources; Insurance, Commerce and Labor; State and Local Government; and others. Senator Spada's legislation included: Mental Health Parity; Protections for Persons with MR/DD; Gift Card Regulations; Credit Card Privacy; Do Not Call; Anti-Terrorism; to name a few.

Other public and private sector work includes employment with the Internal Revenue Service, the U.S. Department of Labor, and as a partner in an accounting firm. Mr. Spada, a Cleveland native, received his BBA in Accounting from Cleveland State University, and an MBA in Systems Management from Baldwin Wallace College. He served in the U.S. Army as a Systems Analyst. He and his wife Mary live in North Royalton and are strong advocates for mental health issues and awareness.

## Highlights of the All-Ohio Community Psychiatry Conference

### Magnolia Clubhouse and our Carriage House Clinic

Pat Runnels, M.D., our psychiatrist at the Carriage House Clinic, and I made a presentation at this year's All-Ohio Community Psychiatry Conference sponsored by Case Western Reserve University School of Medicine, Department of Psychiatry. Jonathan Sheldon, a member who uses the clinic, and Paula Feher, a staff member, also shared their perspectives. The conference is held every two years, and it was at this conference two years ago that the Carriage House Clinic idea was born.

This year, the conference was focused on Integrating Care, and the Clubhouse was asked to conduct a workshop presentation about the Carriage House Clinic. The workshop was well attended and many in the audience were psychiatrists who have heard great things about the Clubhouse through their patients. We invited them all to visit.

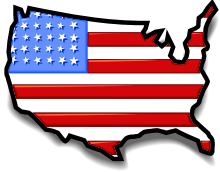
There was much helpful information at the conference. **Ohio Congresswoman Marcy Kaptur**, who is a 15 term representative, gave a very compelling dinner presentation. In the beginning of her remarks, she shared how much she thinks of the Clubhouse Model and how glad she is that Ohio has Magnolia Clubhouse. She also offered to assist us and our US Clubhouse Coalition. Congresswoman Kaptur helped establish the Congressional Mental Health Caucus in 2003. Her presentation was clear and impassioned and we are fortunate to have her as an advocate. Magnolia Clubhouse is looking forward to her visit.

**Tracy Plouck**, our new Director of the Ohio Department of Mental Health, gave a strong luncheon presentation. She is very interested in developing housing and peer driven approaches. She has plans to visit us and is interested in discussing growth for Clubhouses, both here and across the state. We are looking forward to her visit.

Another presenter mentioned in her discussion that she came from Michigan, where the Clubhouse model grew due to the strong interest of the head of the Michigan Department of Mental Health. It was determined that Clubhouses should be implemented by population, to ensure enough needed supports. There are 34 Clubhouses in Michigan, where I had the honor to assist in a training for Clubhouse Directors last year.

*Miriam Rosenthal, M.D., an audience member, shared one reason she attended the workshop. She was at a wedding in Massachusetts, when a guest asked her if she knew what Cleveland was famous for and then shared, "**Cleveland is famous for Magnolia Clubhouse**". This person went on to explain how much her own Clubhouse meant to her and that it saved her life.*

*In Massachusetts, there are 33 Clubhouses. In Ohio, there is one, although one is growing in Dayton, due to a family visiting Magnolia Clubhouse (a future story).*



## Clubhouses Across the Country Pull Together- We are Not Alone

At the end of March, the United States Clubhouse Coalition held a meeting of the Organizing Committee. The work of the coalition is divided into four committees: Federal Funding, Alliances, State Strategies and Research and Evidence Base. The last committee is chaired by myself and David Guest, a member from Thunderbird Clubhouse in Norman Oklahoma. Our committee has defined action steps related to these goals: improve the gathering and sharing of data, promote relationships related to research and policy, and expand research being done to further demonstrate the effectiveness of the Clubhouse model. The overarching goal of the USCC is to advocate for policy and funding to sustain and expand the dissemination of the model across the United States.

## My Journey to Success

I came to Magnolia Clubhouse in April 2007, after being released from the hospital, where I had heard a presentation by the Clubhouse.

Having exhausted my options for recovery, I wanted to give this a try. I was not sure what I would find, having a hard time believing the sincerity or niceness of the members speaking about the Clubhouse. But I knew I needed help.

Slightly overwhelmed at first, I found many purposeful things to do. Having a wonderful sense of belonging, I desired to do more. Gradually increasing my days and hours at the Clubhouse, I was soon attending five days a week, six to seven hours a day. With things to look forward to and my days active, I began to feel better. The more I did, the more I wanted to do.

I once thought I would never be able to work again, but to my surprise, I wanted to try. I announced "I want to try a T.E." . I couldn't believe I said that, but I meant it. I began working at Hickman and Lowder, a law firm that has been an employment partner with the Clubhouse for many years. It was a match made in heaven! I wasn't treated differently,

and felt very comfortable. When I did need to return to the hospital for a brief period, I didn't miss a beat. I went right back to work three days a week, three hours a day.

Meanwhile I was still busy with the Clubhouse; I spoke at an ICCD International Seminar. I also worked on the planning for Mid-States conference and spoke at the Plenary about my T.E. experience.

Having completed my placement with Hickman and Lowder, I was ready to return to the workforce. I began a serious job search just as we entered into the worst economic downturn in recent memory. Yet, I did not let that stop me. I created several resumes and turned my job search into a job. Monday thru Friday I was at the Clubhouse posting five to twenty resumes a day. I did this for over a year. I just knew if I kept trying something would come of my efforts. And it did: last February I interviewed for a part time position at Bank of America. My first day on the job was March 29<sup>th</sup>. I began working 24 hours a week, as a customer service representative.

I have completed my first year, have had several raises, and currently work up to 39 hours a week, with benefits. This month ( April), I was just promoted to Telephone Sales Associate II, and recognized for top performance in hours every month for the 1<sup>st</sup> quarter. Quite content with how things are now, I don't know where I would be without the support of the Magnolia Clubhouse community.

### ***Did you know?***

***Members of Clubhouses have rates of employment 4 to 5 times higher than national norms for people who live with mental illness, and have higher paying jobs and longer job tenure.***



## Blair and University Hospitals Seidman Cancer Center- New Beginnings

When Blair Cochran joined the Clubhouse 2 years ago, he was looking for a place of acceptance and, hopefully, the opportunity to find new employment, as he was not happy with his current job. When he was later laid off, he knew the time was right to start something new.

After doing a short holiday placement with T.J. Maxx, he had the opportunity to start a T.E. at University Hospitals in the Environmental Services department. He worked for 9 months, cleaning many of the public areas of the hospital. Towards the end of his placement, Blair was asked to take part in a 15 week Sodexo training program, offered at the hospital by Cuyahoga Community College, with the prospect of being hired in on-going independent

The job includes cleaning, mopping and/or vacuuming specific areas each day, and requires good judgment to prioritize the most important areas needing to be cleaned during the week. Pastor

Marcis views this as “a shared ministry... as a group, we work together to help others”. The T.E. has been a good opportunity for Andrew...”This has helped me get back to work.” The experience is helping Andrew prepare for an independent job, where he hopes to use his retail and computer skills. We appreciate this new partnership with St. John’s Lutheran Church.

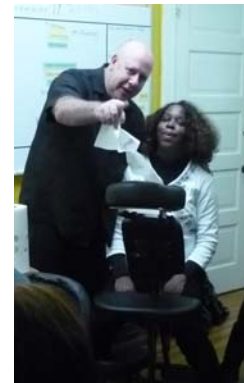


## La Barbería Salon and Spa Pampers Magnolia
