5th Annual Meeting of Magnolia Clubhouse Dedication of the Philmore J. and Constance Mayer Haber Memorial Kitchen



On November 4th, 2009, Magnolia Clubhouse had its 5th Annual Meeting which celebrated the dedication of our new Mayer Haber Memorial Kitchen. Thank you to the trustees of the Cleveland Foundation, Foundation advisors Stanley Adelstein and Jim Berick, and foundation staff Robert Eckhardt and Kathleen Hallissey for supporting our request. You allowed our dream to come true and now we can engage many more members in the

essential work of the Clubhouse kitchen. This work is very popular and also develops skills that allow many of our members to go on in employment.

Our annual meeting this year was quite a celebration. Magnolia Clubhouse has done well over its first five years. We have successfully completed the first phases of our capital campaign and have a start on the last phases- joining the buildings, installing an elevator, and establishing an endowment. Over our first five years we have grown and we have targeted reaching substantially more young adults. Now we are beginning to operate a clinic which will eventually provide the integration of primary care and psychiatric care with the work of the Clubhouse. (continued on page 4)

You will be reading much good news throughout our newsletter and we are happy to share it. However, there is also some not so bright news to share. Due to reductions in the budget for the state of Ohio, substantial cuts were made to the Ohio Department of Mental Health, which, in turn, reduced funding for the ADAMHS Board. The ADAMHS Board consequently had to reduce funding for non-Medicaid services like the Clubhouse by 18%. Magnolia Clubhouse now has a waiting list, and has had to reduce the staff positions from 11 to 10. Since the waiting list began, we have averaged adding a new person a day to the list. We hope that there will be an ability to change this circumstance in the near future, and we hope our private supporters will continue to be generous and will let others know of the work we do, to expand our private support.



We are happy to welcome a new board member since the last edition of our newsletter. Sharon Rosenbaum is the COO of Logic Junction Inc., a Cleveland-based software company. Previously, she worked for General Electric at various locations in the U.S. and Europe. Sharon is originally from South Africa. She came to America to complete an MBA at Duke University, where she majored in International Finance. Sharon has been on the Board and Executive Board of various agencies in Cleveland including Bellefaire JCB, Gross Schechter Day School, Orange Art Center and Park Synagogue. Sharon is married to Bruce and her two daughters attend Laurel School and Gross Schechter Day School. With Health in Mind– Starting Phase of the “Carriage House Clinic” - Psychiatric Services

On October 12 Columbus discovered America, and we discovered our clinic. Magnolia Clubhouse is pleased to have our own medical services for members. Patrick Runnels, M.D. and Kelly Scott, R.N. are working with us to provide what is called Pharmacological Management Services for Clubhouse members.

Lori Ingram was our first member to receive service. Lori says, “The assessment with Kelly was thoughtful, thought provoking and very thorough. Kelly is very kind and welcoming. Dr. Patrick is so knowledgeable that he gives you hope that things will be better, even in a bad time. Having the Clubhouse staff involved helps the staff person, Paula, know me better and understand the challenges I face so we can work together better. It is very valuable for the clinic to be right here - it is so accessible. I wouldn’t have gone otherwise, even though I knew I needed it.”

We are talking with NEON and Neighborhood Family Practice, which are both Federally Qualified Healthcare Centers and are interested in providing the primary healthcare services, when we add those. We are looking forward to having their expertise in working with us.

We are very appreciative of the Mt. Sinai Foundation for providing a grant to us of \$50,000 to start the behavioral healthcare services we began on October 12. We have submitted a proposal for funding to renovate the Carriage House where we will house the integrated care clinic.

Magnolia Clubhouse is generating excitement and enthusiastic support for this project, as so many people are aware of the lack of this kind of care for people who live with mental illness. We hope to change the very tragic current statistic that people who have a mental illness die 25 years earlier than others. With well integrated care, serious health problems can be addressed and prevented.



The Clubhouse will also be developing broader wellness efforts. In addition to our lunchtime walking group, healthy meals, salad option and snack bar offerings, we will be participating in a research project with other Clubhouses and the Clubhouse Program of Research to help members quit smoking. We will also be developing more ways to improve member’s nutritious shopping, cooking and healthy eating, especially on a limited budget or in a care setting. And we will be developing efforts to encourage more exercise to help people who are overweight lose weight, and prevent those who are not overweight from gaining more weight than is healthy. These efforts will also be useful in preventing and treating diabetes and heart conditions.

Over the last five years, we have advocated at many levels. At the federal level, we have had support from the late Congresswoman Stephanie Tubbs Jones and Senator Sherrod Brown. Also, Congressman Dennis Kucinich was the opening speaker at the regional Clubhouse Conference that we hosted in October of 2008. At the state level, we helped pass parity and Medicaid buy-in and have had support from Governor Strickland and Anne Hill (the Governor's Regional Director), from former Senator Bob Spada and from Senator Shirley Smith. We also have the support of Representatives Barbara Boyd and Sandra Williams and from many other public officials across the state. Our support from individuals and foundations in the community has continued to grow. Even in these very difficult times, our supporters continue to show their generosity and we are very grateful. We can't do this without each of you and you are essential to our survival and growth. We are only reaching a small portion of those in need of our work, and we hope to continue to grow. Please help us spread the word. We need your help so that we can help more people be a part of our community of belonging, growth, opportunity and hope.

In the meantime, it is very encouraging to have Director Stephenson valuing and encouraging our work, and to hear more from her about her work. We look forward to furthering our efforts together and to improving the circumstances for people who live with mental illness across the state.



Magnolia Clubhouse Participates in 15th International Clubhouse Conference

A group of us attended the 15th International Conference where we presented on the topics of wellness, development, technology in the Clubhouse. Lori led a workshop for Clubhouse directors and one on becoming a Freestanding Clubhouse.

We were all introduced to a new anti-stigma campaign created by Glenn Close and Fountain House and directed by Ron Howard called, "Bring Change 2 Mind". The film is shot in Grand Central Station with Glenn

Close and her sister, who has bipolar disorder, and many other people, showing how people who have a mental illness are related to everyone else and are a part of our lives.

In part, due to some discussions before and after the conference, Magnolia Clubhouse is working with Fountain House and Independence Center in St. Louis to lead an organized effort to sustain and grow the Clubhouse model across the United States.

The conference was very stimulating and we had a lot of fun together. It is a wonderful resource, this network of Clubhouses around the world. We met and worked with people from China, Sweden, Scotland, Australia, England, Africa, and from many of our states. We also visited the host Club, Vincent House, and they did a great job!



Hope Adelstein Celebrates Her 88th Birthday at Magnolia Clubhouse

Foundation Support: Essential to our Operation

Magnolia Clubhouse is very appreciative to the Ridgecliff Foundation for granting our request for \$30,000 to support the cost of the program annually for 10 members. And we thank Sisters of Charity for providing us \$10,000 to help meet our food costs. We again thank Kim Sherwin for her generous gift of \$15,000 to help us offer reduced priced bus tickets for our members this year, the majority of which depend on public transportation.

We are very grateful to the Deaconess Community Foundation for their ongoing support of \$35,000 this year for capacity building. Thank you to the Kelvin and Eleanor Smith Foundation for their support of \$25,000 for our capital project.

We are also grateful to the Higley Fund of the Cleveland Foundation for \$5,000 in program support. We thank the OakTree Philanthropic Foundation for their ongoing support of \$2,000 and we thank Charter One Bank for their ongoing support of \$5,000. The support of foundations decreases our reliance on increasingly limited governmental funding. As we seek to sustain and diversify our funding, we depend more on foundations to show their confidence in the services and benefits we provide to the broader community. The needs of the community cannot be met entirely by government funding. We appreciate a growing awareness among foundations that ongoing support for programs is a necessity. Foundation support is becoming essential to sustain financial health and provide vital services. We continue to strive to increase our capacity to better meet the need for our services. Sustainable funding has become an even greater challenge and foundation support for operations is essential.



Maybelle Working at TJMaxx

Maybelle King has had a year of many changes. Having lived in various group homes over the past several years, she was eager to be in her own place. Maybelle also hoped to work again, although it had been at least 20 years since she last worked. Being deaf and communicating with American Sign Language also presented additional challenges for Maybelle in the community.

Maybelle joined the Clubhouse in 2008. Paula, the Clubhouse staff member who also communicates in American Sign Language, was Maybelle's link. With two knee replacement surgeries planned for the near future, Maybelle became less optimistic about working. Fast forward to a year after the last surgery, and Maybelle was walking like a new person! She became more active at the Clubhouse and in August of 2009, Maybelle began working at TJ Maxx, our partner in employment in University Heights. Paula worked with Maybelle to teach her the job routine in the stock room. Lula Cabbil, the store manager, has been very supportive and says Maybelle is doing great work! Maybelle tells us at the Clubhouse about working hard and the fast pace of retail, and she is enjoying having more money.



In September, Maybelle moved into her own apartment, where she enjoys the independence of living on her own. She has a Video Phone system, which allows her to stay in touch with others, calling directly to her friends in the Deaf community, and using the Sorenson Video relay service to place calls to any hearing person, including her supervisor at T.J. Maxx. She continues to come to the Clubhouse on her days off, and enjoys telling everyone about her job. The Clubhouse is very proud of Maybelle's accomplishments!
