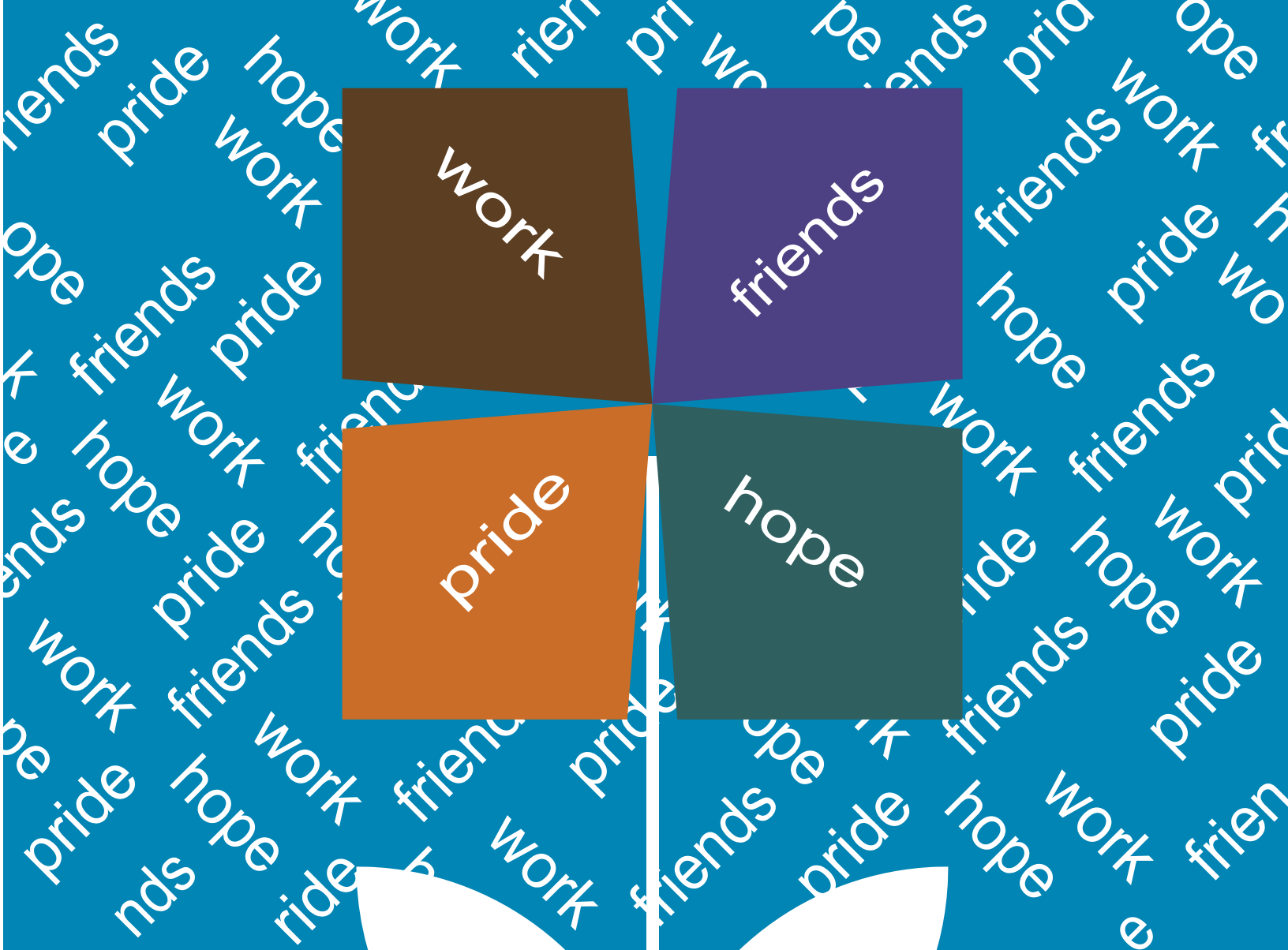

Magnolia Clubhouse (formerly known as Hill House) is a pioneer in the field of psychiatric rehabilitation and has been promoting recovery for adults with mental illness since 1961. Our mission is to ensure that people living with mental illness are respected co-workers, neighbors and friends.

The International Clubhouse model is founded on a belief that meaningful work with others is rehabilitative and benefits more than 55,000 people around the world.

In Cleveland's University Circle, Magnolia Clubhouse is operated by over 350 members, working in partnership with each other and with caring, dedicated mental health professionals. Together, they create a place of acceptance and belonging, a place of growth and hope.

EMPLOYMENT:

75 of our members were supported in employment

31 members worked in transitional employment, **47** worked

independently, and of these **16** were newly employed in the last year

We are also proud of our neighborhood, University Circle and the Uptown businesses of **Accent, the Courtyard Marriott and University Hospitals**, who partner with us in transitional employment. We are working to develop more partnerships with area businesses through the **University Circle Business Association**.

EDUCATION:

27 of our members were supported in educational pursuits including literacy skills, GED, enrichment and college courses.

WELLNESS:

Our innovative **Carriage House Clinic** continued to provide excellent integrated care for our members. Psychiatric services are provided by **Dr. Patrick Runnels**, who is also the director of **University Hospitals Fellowship in Community Psychiatry**, and **Kelly Scott, RN**, who also works in the **psychiatric detoxification unit at the Cleveland Clinic**. **Clubhouse member Denise Fulks** is the administrative assistant for the Clinic.

Primary care services are provided by NEON, a Federally Qualified Healthcare Facility.

Special thanks to the Woodruff Foundation, and in the past to the Mount Sinai Foundation, for providing funding to sustain the operations of the clinic.

RESEARCH:

ODMH Home Choice- Magnolia Clubhouse is one of 2 peer driven organizations in the state asked to participate in this project. The project is focused on transitioning people who live with mental illness, out of nursing homes and into less restrictive residential settings in the community. The study will explore how the Clubhouse supports people in this transition and in increased independence.

Magnolia Clubhouse continued research with **David Biegel, Ph.D. and his team from the MSASS of CWRU**. The research is focused on how the Clubhouse reduces isolation. A second project explores the needs of members' families. **The Woodruff and Cleveland Foundations** provide funding for this research.

The work is a collaboration with **Francesca Pernice-Duca, Ph.D. at Wayne State University**, who is doing research with Clubhouses in Michigan.

We are also participating in a research project looking at the resiliency of Clubhouse members, the work ordered day and relationships in the Clubhouse with **Kimiko Tanaka, Ph.D.** who also conducts research at Fountain House and has expanded this project to Clubhouses in Finland.

ADVOCACY:

This year our advocacy focused on sharing our work and informing our public officials. Clubhouse member and Advisory Board member **Chris Morgan** and his father and Clubhouse Board Trustee, **Chris Morgan, Sr.** gave testimony to the **Senate Finance Committee and the Health and Human Services Subcommittee**. They spoke about the impact of the Clubhouse on their lives and the need for funding for this service, across the state. **We believe the Clubhouse Model of psychiatric rehabilitation should be a primary service in the system, as primary as medication, and be offered to all those who choose to utilize it.** The Clubhouse model has research demonstrating its cost savings and effectiveness.

NEW CLUBHOUSE: We are happy to continue to guide and encourage the new Clubhouse that opened in Dayton, Ohio last year. We hope to see more Clubhouses in Ohio each year.

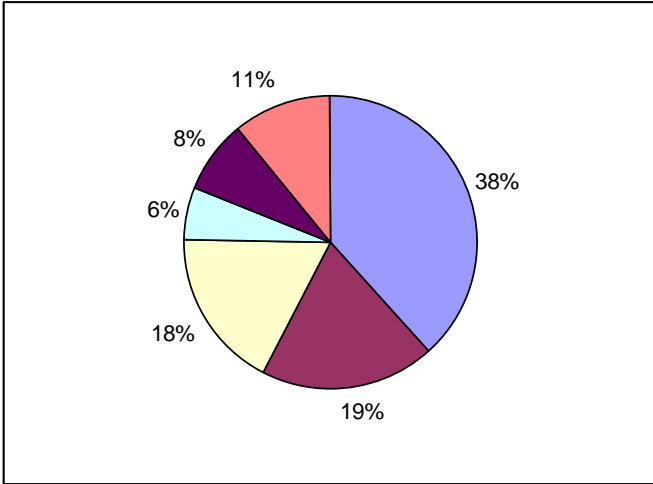

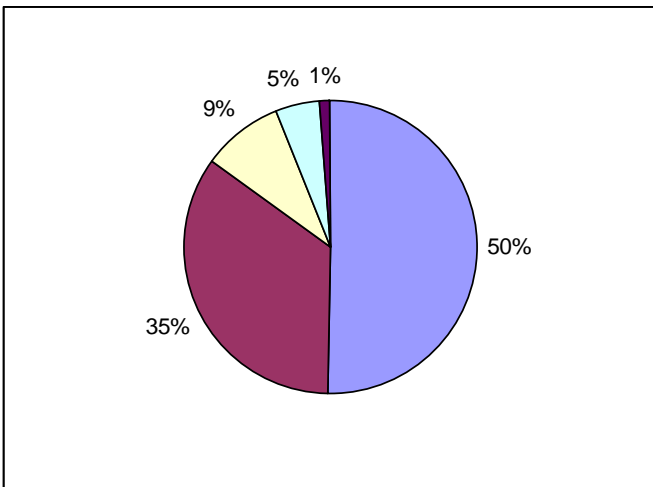

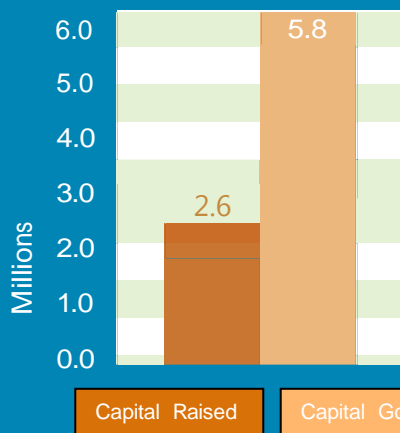
